## European Directive 2011/65/EU (2015/863/EU) and EC 1907/2006 (RoHS/REACH Directives) Information Request Response

To our valued customers,

The intent of this letter is to inform Sussex Wire d/b/a MW Components – Easton's valued customers how Sussex Wire d/b/a MW Components - Easton will respond to all requests for information pertaining to both European Directive 2011/65/EU (2015/863/EU) and EC 1907/2006 (RoHS/REACH Directives). Substances of concern must be reported to the ECHA when the concentration of said substances exceeds the permissible threshold by weight, by both manufacturers and importers of articles containing these substances located within the European Union.

Sussex Wire d/b/a MW Components – Easton thoroughly understands these requirements and is committed to environmental and personal health, however, due to the extensive number of part numbers and materials used, we cannot provide blanket statements of conformance and/or detailed responses for each item upon request. Sussex Wire d/b/a MW Components - Easton is committed to comply with all United States laws and regulations as well as all other countries laws and regulations where our parts are supplied. These laws and regulations change based on the country in which the parts are to be supplied. We are committed to follow all requirements per each country's laws and/or regulations. Due to this, Sussex Wire d/b/a MW Components - Easton will not respond to blanket or specific requests for information without a valid purchase order for said part number. Additionally, as a contract manufacturer we do not control the designs of any parts manufactured at our facility. Due to this, it is our customer's responsibility to specify the required material for each part. Within the limitations of all United States laws and regulations and when it is safe for our employees to be exposed to said materials/substances, Sussex Wire d/b/a MW Components – Easton will follow said specifications or notify our customers prior to manufacture, that we cannot utilize said material/substance.

It is our policy that all regulatory and statutory requirements be documented on the customer's purchase order and/or associated engineering documentation/specifications. Sussex Wire d/b/a MW Components – Easton will review all associated documentation at time of order acceptance to ensure compliance to all applicable regulatory, statutory, and customer specific requirements. At the time of shipment, a Certificate of Conformance will be generated stating compliance to the applicable requirements with the verbiage:

"The above part(s) have been produced and supplied in accordance with all contractual/purchase order requirements. Further, said part(s) have been produced and supplied in accordance with all applicable drawings, specifications, and/or engineering documentation."

Specifically pertaining to European Directive 2011/65/EU (2015/863/EU) and EC 1907/2006, Sussex Wire d/b/a MW Components - Easton will provide a detailed chemical analysis of all raw materials contained within the part(s) shipped and certify conformance to the appropriate regulations. It is only applicable when the Certificate of Conformance states compliance to European Directive 2011/65/EU (2015/863/EU) and/or EC 1907/2006. To whom it may concern,

Sussex Wire d/b/a MW Components - Easton maintains supply chain traceability through certificates of conformance consistent with European Directive 2011/65/EU and 1907/2006 requirements (Current revisions, including any applicable annexes).

Sussex Wire d/b/a MW Components - Easton does not produce and ship parts requiring the Registration, Evaluation, Authorization and Restriction of Chemicals as specified in 1907/2006 (REACH) without exemption, unless noted.

The following statement declares conformance to 2015/863/EU only as Sussex Wire d/b/a MW Components – Easton does not manufacture EEE parts but understands that the parts manufactured at our facility may be utilized in EEE assemblies. Sussex Wire d/b/a MW Components – Easton's finished goods meet the specific requirements of the European Directive 2015/863/EU of the European Parliament on the restriction of the use of certain hazardous substances in electrical and electronic equipment (European Directive 2011/65/EU), without exemption, unless noted, for the following banned substances:

Sussex Wire d/b/a MW Components - Easton has relied on information provided by others in completing this declaration, and that the information has not been independently verified. However, Sussex Wire d/b/a MW Components - Easton's suppliers have provided certifications regarding their contributions to the part(s), and those certifications are at least as comprehensive as this declaration. If Sussex wire d/b/a MW Components - Easton enters into a written agreement, the terms and conditions of that agreement, including any warranty rights and/or remedies provided as part of that agreement, will be the sole and exclusive source of Sussex Wire d/b/a MW Components - Easton's liability, and the Company's remedies for issues that arise regarding information supplied in this declaration.
